Membership - Types, Categories, Year and Fee Due Dates

Membership Types

Associate Members:

All members contributing to the Al-Mehdi Al-Muntathar Union automatically are Associate Members. **Associate Members however do not have voting privileges.** Those wishing to remain associate members are not required to do anything further.

Full Members:

Full Members have voting privileges. Associate Members, who meet the following criteria, can apply for **Full Membership**, using the reverse of this form:

1. Must be a follower of the Jaffari School of Thought.
2. Must have been a resident of London and Surrounding Areas for a period of at least 2 years.
3. Must be aged 18 or over.
4. Must have the Membership Form signed by a Proposer and Seconder, who have known the applicant for a period of at least 2 years. The Proposer and Seconder must be Full Members in Good Standing.
5. Must pay their membership fees using one of the prescribed methods.

All membership forms are subject to the approval of the Board of Directors of Al-Mehdi Al-Muntathar Union.

Full Membership Categories

Family Membership:

Family memberships cover immediate family only, specifically spouses and children less than 18 years of age only. Children aged 18 and over can choose to apply for Full Membership and are encouraged to do so. **They are not covered in the Family Membership.**

Single Membership:

Single memberships cover individuals that do not have spouses or children less than 18 years of age.

Student Membership:

Student Memberships cover individuals who **are students aged 18 to 25 years of age only.**

Membership Year

The membership year follows the annual Islamic Calendar from Muharram to Dhul-Hijjah each year.

Membership Fees Due Dates for Payment and Maintaining Membership in Good Standing

For those NOT using monthly preauthorised payments to pay their membership, either the full amount or an instalment amount must be paid within the first 60 days of the start of the new Islamic Year in order to maintain their membership in good standing. Any outstanding instalments must be paid within the Islamic Year. Any arrears must be paid in order to regain Full Membership in good standing

Important Note

All associate members, without exception, require a Proposer and Seconder to sign their application for New Full Membership, so the entire form must be completed. For subsequent years, when Full Members renew their membership, this form is only to be completed, if the membership category has changed or personal details such as home address, telephone and email address etc. have changed.
